Information Collection, Use, and Sharing

Family Learning Organization is the owner of the information collected on this site. We only have access to/collect information that you have provided us via e-mail or other direct contact with you. We will not sell, rent, or trade your data to anyone.

We will use the information you provided to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, except what is necessary to fulfill your request, such as ship an order.

Information is requested from you on our order form. To buy from us, you must provide contact information and financial information. This information is used for billing purposes and to process your orders. If we have trouble processing an order, we'll use this information to contact you.
